Message from the Director

The 2022-2024 period has been marked by the aftermath of the pandemic, political instability, wars, polarization of societal values, and the impacts of climate change. These challenges highlight social inequalities and their repercussions on the most vulnerable groups.

In this context, the USI and its partners are more committed than ever to deploy strategies that improve access to quality health services. These actions extend to conflict zones, urban centers, and remote regions. The USI continues its collaborations in West and Central Africa and the Caribbean while establishing new partnerships in Asia, particularly in Bangladesh and the Philippines, as well as in the Middle East. Its activities are also expanding in Tunisia and Morocco.

Requests for collaboration in specific areas are increasing, such as One Health, universal health coverage, and NEXUS approaches. Strengthening competencies in related disciplines (management, nursing sciences, medicine, midwifery, optometry, etc.) remains central to our actions. A strong emphasis is placed on modern teaching tools, such as simulation, distance learning, and educational technology, to ensure that partner countries have quality human resources in sufficient numbers.

With 35 years of global engagement, the USI has built an extensive network of active partners in over 34 countries. This community contributes to the development of adapted policies and programs, field interventions, and knowledge sharing to improve population health.



Caribbean

Optometry Program - Phase II

Country: Haiti

Dates: 2022-2025

Partners: UdeM (USI, School of Optometry, School of Public Health), Optometry Giving Sight, Brien Holden Vision Institute Foundation, School of Optometry of Université d'État d'Haiti (UEH)

Funding: Optometry Giving Sight

Despite the country's sociopolitical context, most courses in the program are delivered virtually by local and international instructors. A partnership has been established with an internship site in the northern department of the country, where the first graduating cohort of 11 students completed a four-week internship. This hands-on experience provided exposure to various optometry techniques and ophthalmological pathologies.

Two graduates from the first cohort were awarded the Queen Elizabeth II Scholarship for a four-month stay at the School of Optometry at the Université de Montréal to further enhance their technical skills.

Implemented in collaboration with the School of Optometry at the UEH, the project aims to improve access to eye health services and refractive error treatment for the Haitian population by promoting high-quality eye care services and enhancing their geographical accessibility.

To achieve this goal, the project focuses on the following key areas:

- Enhancing the quality of teaching and learning by strengthening the training program
- Supporting the sustainability of the training program through the development of a local faculty
- Increasing the number of qualified eye care providers to deliver quality eye care to the Haitian population, particularly in underserved areas
- Promoting the profession of optometry in Haiti

ACOSME - Support Project for the Mother-Child Health Continuum

Country: Haiti

Dates: 2016-2022

Consortium: USI/UdeM, CECI

Partners: Ministry of Public Health and Population (MSPP in french) and Department of North

Funding: Global Affairs Canada

Carried out in collaboration with the MSPP of the Republic of Haiti, the ACOSME project contributed to reducing maternal and infant mortality in Haiti. The project aimed to:

1. Improve the delivery (availability and quality) of an essential continuum of services that meet the needs and rights of mothers, pregnant women, and children ;
2. Enhance the use of healthcare services by women, their families, and young people ;
3. Raise awareness among Canadian audiences about health and rights issues affecting mothers, pregnant women, newborns, and children under five in Haiti.

- Construction and equipping of three health centers
- Strengthening of 19 institutions in terms of service availability and quality of care for women
- Reduction in infant mortality rates in the region
- Increased attendance at prenatal clinics

Haiti Support Plan

Country: Haiti

Dates: 2023-2026

As part of the Quebec government's «Committed to Haiti» program, implemented through the 2023-2026 Support Plan, USI received \$500,000 CAD in funding from MSSS for three sub-projects over a three-year period:

1. Support Project for the Northern Health Department in Haiti
 - Focuses on improving access to primary healthcare for the most vulnerable groups.
 - Implemented by the Ministry of Public Health and Population (MSPP) through the Northern Health Directorate.
 - Collaboration with Women's Committees for Healthcare Services and the Departmental Coordination of the Ministry for Women's Affairs and Women's Rights.
2. Visual Health for All: Supporting Quality Eye Care Services in Cap-Haïtien
 - Implemented by the School of Optometry at the Faculty of Medicine and Pharmacy of UEH.
 - In collaboration with the Cathy Pearson & Fortune Previl Memorial Clinic.
3. Strengthening Crisis Response Capacity for a Resilient Healthcare System (to come)
 - A project supporting crisis management training for Haitian healthcare managers.
 - Training conducted in collaboration with ESPUM and the Faculty of Medicine and Pharmacy of UdeM
 - Implemented through the DESS in Health Systems Management program and the National Unit for Health Emergency Management of MSPP.

TUMAINI – Health and Rights of Women, Adolescents, and Children

Countries: Democratic Republic of the Congo & Burundi

Dates: 2022-2027

Consortium: UdeM (USI and Observatoire Hygeia), Panzi Foundation

Partners: Denis Mukwege Foundation, Lawyers Without Borders Canada, Global Strategies

Funding: Global Affairs Canada

Implemented by USI and the Observatoire Hygeia of UdeM in collaboration with the Panzi Foundation, TUMAINI supports the activities of the Panzi Foundation and Panzi Hospital. Stemming from Dr Denis Mukwege's vision and with the support of the UdeM, the project strengthens holistic services for survivors of sexual and gender-based violence. It enhances the capacities of the Panzi Foundation in four health zones in South Kivu and one in Kinshasa (Democratic Republic of the Congo), as well as in four territories in Burundi.

Key Components of the Project:

1. Improving the delivery and management of healthcare services.
2. Enhancing the sociocultural, financial, and geographical accessibility of healthcare services.
3. Promoting policies, legal frameworks, and healthcare services based on research-driven knowledge.

The project engages multiple faculties of Université de Montréal and incorporates a cross-cutting action-research component. Designed with an equity-based approach, the initiative prioritizes reaching the most marginalized and vulnerable populations. For sustainability and long-term impact, the project focuses on strengthening local resources, integrating environmental concerns, and advancing gender equality and human rights. These aspects are embedded into both specific interventions and cross-sectoral strategies, ensuring significant impacts at the local and provincial levels.

ASSK – Access to Health Services in Kinshasa

Country: Democratic Republic of the Congo

Dates: 2018-2024

Consortium: Santé Monde and USI/CHUM

Partners: Ministry of Public Health (MSP in french), City-Province of Kinshasa

ASSK aimed to improve the health of women, children, and adolescents living in the province of Kinshasa. It targeted seven health zones and included two main components:

1. Improvement of essential health services, focused on building technical capacities and ensuring the availability of material resources to enhance the delivery of quality healthcare services, strengthened management capacities, hygiene practices, and biomedical waste management, prioritized women's, adolescents', children's, and newborns' health, as well as sexual and reproductive health and rights.
2. Utilization of essential health services, focused on developing awareness and sensitization capacities among health center staff, general reference hospitals, and community actors to promote best practices in sexual and reproductive health, and aimed to increase financial and geographical access to healthcare services for populations in the targeted health zones.



Key Components of the Project:

- 28 officials from the Ministry of Public Health, Hygiene, and Prevention, along with project experts, received training in sexual and reproductive health and rights, while 49 individuals were trained in adolescent- and youth-friendly health services ;
- 156 adolescent peer educators from 16 schools across four health zones were trained in adolescent sexual and reproductive health and rights ;
- Two Adolescent Committees (CADO) were established in the Kasa-Vubu health zone and the Nkieme health area. These committees serve as a bridge between adolescents and health centers, conduct awareness campaigns on SRHR, and advocate for adolescent health and rights ;
- Two Women's Health Service User Committees (CFU) were established to improve community engagement in healthcare ;
- The use of childbirth services at the Kinkosi Reference Health Center increased significantly, from an average of 4 to 40 deliveries per month ;
- One scientific article and two project capitalization reports were published, contributing to knowledge-sharing and policy development.

YELLEN – Rights and Innovations in Sexual and Reproductive Health

Country: Mali

Dates: 2020-2025

Consortium: USI/CHUM, CECI

Partners: Regional Directorate of Health (DRS), Regional Directorate of Social Development and Solidarity Economy (DRDSES), Regional Directorate for the Promotion of Women, Children, and Families (DRPEF), National Office of Reproductive Health (ONASR), Regional Federation of Community Health Associations (FERASCOM), and the Academies of Kayes, Nioro, and Kita.

Funding: Global Affairs Canada

In 2022, YELLEN launched the pilot project Ki La Di («to advise you» in Bambara) aimed at raising awareness among adolescents in the Kayes region about sexual and reproductive health and rights, gender equality, and gender-based violence.

The project uses digital tools such as WhatsApp, Facebook, and an Android application to provide information and interactive discussions while organizing awareness activities in the four targeted high schools. The goal is to prevent risky situations affecting adolescents' physical or mental health and to improve their knowledge of their rights, facilitating access to healthcare services and advocacy efforts.



YELLEN aims to contribute to reducing gender inequalities in sexual and reproductive health and rights for women and adolescents in seven districts of the Kayes region: Bafoulabé, Diéma, Nioro, Ossoubidiagna, Sagabari, Séféo, and Yélimané.

It is based on the assumption that increasing the decision-making power of women and adolescents for better control over their health will promote the use of quality sexual and reproductive health services adapted to their needs.

It proposes an innovative collaboration model aimed at harmonizing the work of health service providers, civil society actors, particularly women's groups and decentralized local authorities.

YELLEN provides technical and material support to health structures and the public health system. It raises awareness and mobilizes communities in synergy with these interventions. It strengthens the skills of healthcare system actors to sustainably improve the quality and availability of care and increase the accessibility of health services.

ELUZO – Women Fighting Against Zoonoses

Countries: Senegal and Burkina Faso

Dates: 2023-2028

Consortium: UdeM (UdeM International, USI, Faculty of Veterinary Medecine, ESPUM, and other faculties involved in the One Health hub) and University of Guelph



ELUZO – Women Fighting Against Zoonoses aims to improve community health and promote equitable One Health empowerment for poor women and girls in regions of Senegal and Burkina Faso where the prevalence of zoonotic diseases at the human-animal-environment interface is high. Its interventions are structured around three main pillars:

1. Strengthening community capacities and increasing the participation of women and girls in the fight against zoonoses.
2. Enhancing and integrating surveillance, prevention, and control systems while considering gender equality issues.
3. Empowering women and girls economically by protecting their livelihoods.



Support for Donka University Hospital

Country: Guinea Conakry

Dates: 2022-2024

Partners: Netsen Group, USI/CHUM, Ministry of Health and Public Hygiene

Funding: Netsen Group

This mandate was awarded to USI by Netsen Group, the concessionaire of CHU Donka, which manages the hospital under a concession contract signed with the Government of Guinea. USI's technical assistance focused on:

- Supporting the hospital's opening process for this university hospital with over 500 beds
- Providing advisory support on the hospital and care project
- Planning the gradual opening of all hospital services
- Governance, human resource management, service organization, and development
- Training and establishing structured operational mechanisms between the hospital, universities, and health sciences schools
- Implementing an internal quality evaluation system and monitoring and evaluation of results



Maghreb and the Middle East

Technical Support Project to the Ibn Sina College of Nursing and Midwifery (ISC) in Nablus

Country: West Bank

Dates: 2022-2027

This project aims to contribute improving the quality of healthcare in the West Bank by strengthening qualified human resources through the development of the Ibn Sina College. Its objectives include the construction of a building adapted to the current and future needs of ISC resilient, energy-efficient, and gender-sensitive; the development of high-quality initial and continuing education programs tailored to the healthcare needs of the population for nurses, midwives, and other health professions; and the integration of gender issues into ISC's governance and training programs. USI supports the development and implementation of the gender strategies, the creation of a master's degree and the strengthening of research at ISC.

Skills for Employment Project in the Francophonie

Countries: Morocco and Lebanon

Dates: 2017-2022

Implementation: UdeM (USI, Vice-Rectorate for Community and International Partnerships, Faculty of Nursing, Faculty of Medicine, and University Pedagogy Center), Université St Joseph de Beyrouth (Faculty of Nursing, Occupational Therapy Institute, Public Health Institute), Université Balamand de Tripoli (School of Architecture, Lebanese Academy of Fine Arts, Faculty of Health Sciences), Université Mohammed V de Rabat (University Entrepreneurship Center, Faculty of Medicine and Pharmacy), Université Cadi Ayyad de Marrakech (Faculty of Medicine and Pharmacy), Fikra Foundation

Funding: Global Affairs Canada



Key Components of the Project:

- Creation of the first university program in occupational therapy in Lebanon ;
- Establishment of a family medicine program in Morocco ;
- Strengthening of the nursing sciences program in Lebanon ;
- Training and support for teams of university pedagogy multipliers, business creation advisors, and coaches for young entrepreneurs ;
- Adoption of inclusion policies prioritizing students and staff with disabilities ;
- Creation of sustainable structures to support students throughout their academic journey.



The Skills for Employment Project was a Morocco/Lebanon university partnership aimed at supporting four partner universities. It serves as a relevant example of the crucial role universities play as development partners. The project improved the alignment of services and training programs with labor market needs while promoting inclusivity in Morocco and Lebanon. Partner universities received support on multiple fronts, including governance, entrepreneurship, program development, university pedagogy, digital transformation, student success and academic journey support, as well as the integration of diversity and sustainable development considerations.

Collaborations with the Mohammed VI Foundation for Science and Health



Country: Morocco

Dates: 2023-2028

Partners: USI and various faculties of UdeM, including Medicine, Public Health, Nursing, and Education Sciences

A five-year partnership agreement was signed between the UdeM and the Mohammed VI Foundation for Science and Health.

The project facilitates various collaborations aimed at student and faculty mobility, as well as exchanges on academic topics such as research and innovation, learning and teaching through simulation, pedagogy in health sciences, and hospital management. These collaborations were established with different partners of the Mohammed VI Foundation, including the International Hospital, the University of Health Sciences, and the Center for Research and Innovation.

The members of the Moroccan delegation were accompanied by Karina Dubois-Nguyen, director of USI, Dr. André-Paul Vénor, principal coordinator at USI, and Dr. Réjean Hébert, previous dean and associate professor at ESPUM.

Certified training program for the Operationalization of the National Health Policy

Tunisia's Minister of Public Health, Dr Ali Mrabet, accompanied by representatives of the Ministry and implementing partners.

The Certified training Program for the operationalization of the National Health Policy (PCO-PNS in french) project supported the implementation of the National Health Policy to achieve the government's 2030 vision, a health system reform aimed at progressively restructuring the organization of healthcare services, health financing, and governance. Around 100 executives and managers from various levels of the health network, representing all governorates of the country, benefited from a capacity-building program in management through certified training and coaching by Canadian and Tunisian experts.

Within a few months, the project enabled the planning of 18 large-scale operational projects addressing real professional situations. These projects are ready to be deployed at different levels of the healthcare system and align with the seven pillars of the new health policy (1. Governance, leadership 2. Financing and health insurance 3. Health human resources 4. Health information systems 5. Infrastructure and equipment 6. Drugs, medical devices and other pharmaceutical products 7. Health service delivery). The project's success and the enthusiasm generated through the training program validated the andragogical and pedagogical approach used.



Key Results of the Project

- Development of an educational toolkit of over 250 reliable and easily accessible resources to facilitate the transfer of acquired skills to new groups of Tunisian managers.
- 120 hours of training provided to 99 managers.
- Planning of 18 large-scale operational projects ready for deployment.

ProNurse - Women's Empowerment through the Professionalization of the Nursing Sector

Country: Bangladesh

Dates: 2021-2026

Implementation: Cowater International, UdeM (USI and Faculty of Nursing), Canadian Association of Schools of Nursing and Naripokkho

The work environment is very important for keeping our body and mind healthy and productive. After the renovations of key learning facilities, supported by the ProNurse project, we now have a standard workplace to provide quality services. – Modina Khatun, Director of the College of Nursing, Mohakhali, Dhaka.

This project aims to strengthen the voice, influence, and autonomy of nurses in the healthcare sector in Bangladesh. It focuses on improving the quality of education provided to nurses in both the public and private sectors, enhancing the performance and professional status of nurses, and creating conditions that foster greater participation of nurses in the healthcare sector in Bangladesh. As part of this project, USI and the Faculty of Nursing at the University of Montreal contribute specifically to improving the quality of training for nurses and educators in both public and private sectors.

GRASP-UHC - Gender-Responsive Systems Approach to Universal Health Care

Country: Philippines

Dates: 2024-2029

Implementation: Plan International, Zuellig Family Foundation and USI/UdeM

Funding: Global Affairs Canada

The GRASP-UHC Project supports government efforts to improve health outcomes, particularly for vulnerable populations, by providing affordable and equitable access to health goods and services. Through an integrated, rights-based, and locally driven approach, the project will contribute to improving health, including sexual and reproductive health, for the most vulnerable Filipinos, especially women and young girls.

Implemented in partnership with Plan International, the Zuellig Family Foundation, and USI, the project builds on the consortium's experience in underserved communities, its knowledge of the Philippine health systems, and recent consultations conducted in the four targeted provinces. USI supports action research, human resources in the integration of the gender dimension and strategies for the implementation of Universal Health Care(UHC).
